#### **PRESIDENT'S REPORT**

#### April 18, 2017

We started the period with the resignation of David Jelin. So, now we are faced with moving forward with the improvements that David started at the RV Park. Ricki has taken over the management of the park and has moved forward with the necessary changes. The gate will be installed later this month and we will finish everything else from there. We have had a request from someone to replace the caretaker in the park that we will discuss at the meeting.

We have had numerous complaints about the resident of 286 Taylor and Bobbie has moved forward in resolving the issues with the neighbors. We had a break in on Woodcock that happened in the middle of the day and reminds us that we need to take precautions and pay attention to what is going on in our neighborhood.

Budget meetings and requests will start next month so please have your basic figures for your department ready to go.

#### TREASURERS REPORT

#### April 2017

We are through the first Quarter of 2017. SunLand is still experiencing growth as far as new homeowners. Between January 1 and March 31, 2016, we had 11 home sales. Between January 1 and March 31, 2017, we have had 18 home sales. This is supposed to be the "slow" part of the year. As of March 31, we have collected \$199,654 in dues which represents 97.8% of the expected amount. Thanks to Ricki, I expect to have the remaining dues collected within next couple of weeks. We have collected \$15,703 in RV income which is more than the expected total of \$15,350. We are currently under budget in expenses. <u>Not</u> including the reserve account (since we fully fund beginning of the year), we have spent \$46,660 or 22.5% of our expense budget of \$207,013.

I have completed the budget worksheets for the 2018 budget. I need everyone's comments and revisions by 2nd week in May. I will present the Board with a tentative budget at the May monthly meeting. Board Members will present any additional comments/revisions prior to June monthly meeting and we will vote to tentatively approve budget. If budget is not finalized, this will occur in July so that budget can be published in the August newsletter.

**Rental Coordinator Report** 

April 2017

The month has been relatively quiet except for two issues. One pertains to a 50-ish year old man who may be mentally ill, because after a year of problem-free tenancy, he has become paranoid, aggressive, and problematic. He believes that people are ringing his doorbells and that Sasquatch is lurking behind the trees near his home. His mother is the landlord. When I told her of the Sasquatch allegations, she said, "Oh, I know. I've SMELLED him". Wow. Who know that Sasquatch lurks in Sunland. In any case, the man got an aggressive pit bull that was barking a lot and threatening neighbors. Sheriff deputies were called and they took the dog to the animal shelter. Then, the man became threatening and aggressive toward neighbors, who are extremely frightened of him. His behavior also included blaring loud music at 1AM and removing the mufflers from his car, with expired tags, and revving it loudly at 6:30AM, and driving it up and down Taylor Blvd. He has been ordered to cease and desist and threatened to be evicted if there are any more incidents. His mother pleaded leniency, because he would be homeless and on the streets if evicted. We are closely monitoring the situation and hope that his plans for independence occur soon and he can then find another place to live. I've checked with one of the neighbors a couple of times to ensure no more bizarre behavior from the tenant.

The other issue was a complaint of an illegally parked trailer and an illegally parked RV on San Juan Dr. I investigated and learned that the RV was caught in limbo due to Dave's departure from the RV committee and was awaiting a space in the RV lot. I drove by on April 6<sup>th</sup> and the RV was gone, so I assume that the application was processed and a space in the RV lot was found. The utility trailer was owned by a couple with an extremely ill child. They asked for 2 weeks of leniency while their daughter was in surgery and hospitalized. I drove by on April 6<sup>th</sup> and the trailer was already gone.

I also followed up with the complainer of the barking Chihuahua on Leslie and was told that all has been quiet.
