1. Call to Order

a. Fred Smith called the meeting to order at 10:00A.M.

2. Public Comments

- **a.** Larry Laing: Safety concerns about dead trees. Fred Smith responded that trees will be taken down. Mr. Laing requested improvement in board/resident communication.
- **b. Mr. Ogden:** Presented *Map Your Neighborhood* proposal. Water purification \$2,000.00; for outages, hand operated. Fred Smith advised communication with Mike.
- **c. Lloyd Taylor:** Noted the removal of the 15MPH signs and golf carts on the roads. Fred Smith responded that the Sheriff's Department has deemed carts legal with SunLand.
- **d. Bonnie Mayfield, Division 11:** Requested clarification on resolution of her application concerning North Slope trees. Jac Osborn stated that he had already notified her of approval.
- e. Discussion of CC&Rs
 - i. Governance: SLOA has authority over Divisions SLOA CC&Rs supersede Division CC&Rs.
 - 1. Fred Smith moving forward to update CC&Rs
 - a. Current CC&Rs do not follow state regulations; have not been updated in 10 years.
 - b. Changes have been submitted to SLOA attorney for legal review and alignment
 - c. New version meets code
 - 2. Tom Merrill decisions must be concurrent with legal determination

- a. Fines: Should we enforce or write off fines?
 - i. Options discussed: dollar threshold, small claims court, property liens, foreclosure

6. Committee Reports

- a. Architectural, Jac Osborn
 - i. Jac Osborn requested a follow-up assistant
 - 1. Tree removal must be done by a licensed arborist
- **b. RV**, David Jelin
 - i. Proof of registration and insurance required; forms must be updated
 - ii. In process of getting estimates for fence/gate repair
 - 1. Barbed wire is damaged
 - 2. Need assessment help for southern edge of RV lot
 - a. Fence braches over 10'; Fred Smith suggested limb all
 - **b.** Limbs hitting lights
 - iii. Plumbing: hose bibs need replacement
 - 1. \$2,000.00 bid from Gillis Construction on schedule

- iv. Resident guard living on site for 2+ years
 - 1. Evidence that he is letting people onto property; suggest contract be terminated
 - 2. Phone charge monthly; however, no phone line
 - **3.** Fred Smith has sent letter to Patrick requesting history
- c. Security and Roads, Phil Merlin
 - i. We have been notified by Mark Ozias, County Commissioner, plans are being developed for Woodcock/Sequim Dungeness roundabout
- d. Landscaping
 - i. Greenbelts work finished on vacant lots
- e. Communication, Missy Church-Smith
 - i. Survey re.SLOA website in development through Survey Monkey
- f. Rentals, Bobbie Piety
 - i. Quotes for scanning bids from \$3500.00-\$6000.00, \$.15/page
