- Vision going forward
  - Would like to establish an initiative taking and forward-thinking board, proactive rather than reactive
  - Develop a detailed position description requirement document to act as a guideline for future board members.
  - Strive to develop standard operating systems throughout all SLOA operations
  - Look into potential outsource services
  - Reconsider the frequency of Board Meetings.
- Reevaluate definition of what is considered an RV, especially as it pertains to conversion or Sprinter vans used as daily drivers
- Architectural planning and guidelines
  - House colors, fence types and their current location restrictions must be reevaluated
- Recreation amenities and facilities
  - Are they right type, do they serve the majority of members rather than just a small group

- Have been assigned to review all building requirements and architectural guidelines and/or policies
- Will require greater detail on Architectural Request Forms and require owners to sign form after project is completed. Architectural committee member will then acknowledge completion with their own final signature
- Grievance committee grievance committee structure needs to be reevaluated, and a
  policy put in place that encourages participants to be prepared for a grievance meeting
  so that the time can be best utilized.

# Landscape, Nik Skogsberg

- Continue to work to wrap up those violations that were reported over the summer
- Working to develop new procedures and policies to streamline and improve communications. Continuity and clarity are forefront.
- Working to provide educational events to SLOA residents covering deer resistant landscaping and other helpful tips
- Reached out to residents that had previously expressed interest in forming a volunteer group to assist residents in need with landscaping tasks
- Updated list of Landscape service providers, verified new clients were being accepted
- Landscape and Recreation would like to send out a survey to residents so that they can vote on who in Sunland has decorated with the most spirit (Halloween)

# Recreation Report: Kirsten Rene

- Thanks to all picnic volunteers and all that attended
- Pool 2025 Season recap
  - o 230 passes issued
  - o 16 to nonresident SGC members
  - Average 76 guests checked in per day,
  - 356 water aerobics sessions were purchased
  - Experimented with extending the pool hours on Fridays, will consider offering the extended hours again in 2025.
  - Have a meeting with pool manager and Tim Mannor to go over pool maintenance needs/concerns
  - Tennis/Pickleball courts vandalism- temporary solution
    - B. Eichhorn received a bid to have the driveway regraded and cement barrier blocks installed. The blocks are a temporary solution to the ongoing problem of vandalism caused by driver(s) spinning circles in the gravel parking lot.
  - Pickleball schedule
    - Exploring various options for schedule and open play that will be equitable for all

#### Greenbelt: K. Renehan

- Entrance will be decorated for the holidays on November 27, additional LED lights will be added to the display
- The water at the front entrance and tennis courts has been turned off. The lines will be drained.

# Roads and Safety: Open position, comments by Bob Eichhorn

- License plate recognition cameras have been installed
- Streetlight at Sunset and Leslie Ln. will be evaluated by electrician on October 18

## **RV: John Hammond**

- 85% Occupancy
- Restriped lot and returned parking blocks to proper positions, repainted signs and repaired barbed wire
- Reiterate that the RV Lot does not have surveillance cameras
- Will be marking driving lanes in preparation for new gravel to be delivered
- Exploring options to solar charge the gate in addition to allowing users remote access
- Attaining bids to straighten fence along the southeast side of the lot
- Next 24 months will be looking into upgrading the electrical service along the outer fences

- Gathering Place reservation system equitable solutions
  - o Limit number of reservations a group may make each month
  - Limit total number of hours
  - Limit amount of advance booking to 6 mo.
  - o Consider charging a fee if the reservation holder does not cancel in advance

- Tenant Use of Amenities K. Rene
  - O Proposed Changes To Rules and Regulations in bold text:
    Use of swimming pool and tennis/pickleball courts use of these facilities is for SLOA members and their guests. Guests are not permitted to use the facilities on their own and must be accompanied by the SLOA member. SLOA members are allotted one pool pass per household. In cases where SLOA members have tenants, the SLOA member can transfer eligibility of their pool pass and use of courts to the tenant if desired. Rules for use are posted at respective facilities. It shall be the responsibility of the homeowner to oversee guests' conformity to the rules.

John Hammond moved to approve the revision to the Rules and Regulations as presented, second by E. Skogsberg. The motion carried, all in favor.
