ARTICLES OF AMENDMENT  
OF  
SUNLAND OWNERS ASSOCIATION

SECTION I

ARTICLE III is amended as follows:

After the word "Washington" in line 6, there is added the following legal description:

"Situating in Clallam County, Washington, to-wit:

"The North one-half; the North one-half of the Southwest Quarter; and the Northwest Quarter of the Southeast Quarter, all in Section 8, Township 30 North, Range 3 West, Willamette Meridian, Clallam County, Washington, containing approximately 440 acres"

hereinafter referred to as "SunLand project"

SECTION II

ARTICLE III is further amended as follows:

After the portion typed "ation" in line 9, there is added the following:

"and shall be accepted by an approved vote of not less than sixty-six and two-thirds percent (66-2/3%) of the lot owners voting in person or by proxy at any duly called meeting, together with the Association being entitled to serve as trustee of any real property for the lot owners in the plats of SunLand and SunLand Shores" (the balance shall remain as set forth in the ARTICLE III).
